# Super Tease & Next On Teases

## Key content steers from ID President:

- Need escalation in the last 20-30 secs of Super Teases
- Don't always have to be so literal to series
- Take artistic liberties: for ex. strobe the footage to make it choppy
- Make it clippy & hyperbolic
- OK to keep the viewer guessing and be mysterious about the story and what's actually going on
- If the viewer is disappointed with a future ep after seeing the tease, that's OK!
- Don't necessarily have to tell the full story, focus on what will get the viewer to come back
- Sometimes it's better to convey the organizing principle/conceit of the show rather than trying to cover all of the individual stories (see Death by Fame ST: https://app.frame.io/presentations/2d7328a2-41e5-4e99-8847-288719263bf7)
- What are we selling in a given season? New series will need to sell something more/different than an established one, which might be focused on emotional breadth over show's conceit

## Super Tease: General Guidance & Requirements

- All materials must be cleared for press, promotional and social media use in all media, all markets worldwide, in perpetuity, or as required in the contract.

- \*Important distinction:

A Super Tease for a Limited Series "doc-buster" = a series with one single overarching story (premiering over 2-3 consecutive days/nights) has different requirements from a Super Tease for a series with standalone episodes covering separate cases throughout. Continue onto additional slides for further guidance.

- Expect RC/FC/PL reviews, with standard turnaround time for notes.
- Final version upload to the portal shall follow Program Master File technical specifications.
- Final version to deliver:

1) to the portal under the <u>premiere episode  $\rightarrow$  Teases/Promos</u> category, and 2) additionally, to the show frame.io folder  $\rightarrow$  super tease subfolder

• Can deliver after the masters have delivered, and up to 1 week in advance of premiere (but earlier is ideal).

## Super Tease Guidance specific to series with stand-alone eps

covering separate cases throughout the season run (ex: 6x60s, 8x60s, 10x60s)

- Extended promotional content for the series as a whole.
- Features the best and most salacious bites/scenes/images from upcoming episodes, but <u>no</u> material from the premiere episode.



## LAYOUT

#### **Series Title Treatment**

- "THIS SEASON ON" text above the title graphic / series title
- + a narrator stating the words shown (if series has a narrator)
- 3 seconds max

### **Series Content**

- Compilation of scenes per previous instructions
- 57 seconds max
- No title end card needed / end on content

## Super Tease Guidance specific to Limited Series "doc-busters" =

## a series with one single overarching story (ex: 3x60s, 4x60s and 5x60s) premiering over 2-3 days/nights

- Extended promotional content for what the audience can expect to see in the day/night 2 episode(s).
- Features the best and most salacious bites/scenes/images from upcoming episode(s) in night 2, but <u>no</u> material from the night 1 episode(s) (or night 3 episode(s), if applicable).
- If there are 2 episodes premiering on day/night 1, the final/approved version portal upload should go <u>under episode 2</u>.

#### Limited Series ("doc-buster") Title Treatment

- "NEXT TIME ON" text above the title graphic / series title
- + a narrator stating the words shown (if doc-buster has a narrator)
- 3 seconds max

### Night 2 content only

- Compilation of scenes per previous instructions
- 57 seconds max
- No title end card needed / end on content

## Next on tease(s): General Guidance & Requirements

- All materials must be cleared for press, promotional and social media use in all media, all markets worldwide, in perpetuity or as required in the contract.
- TRT :20
- \*Important distinction:

Most required next on teases will be for series with stand-alone episodes covering separate cases throughout the run. However, a next on tease for a Limited Series "doc-buster" will be required in the instance of a premiere drop over 3 consecutive days/nights (ex: a 5x60). Continue onto additional slides for further guidance.

- Expect RC and FC approvals with standard turnaround time for notes.
- Final version uploads to the portal shall follow Program Master File technical specifications.
- Final versions to be delivered to the portal to the **Teases/Promos category.**
- Can deliver after the masters have delivered, and up to 1 week in advance of premiere (but earlier is ideal).

[ID internal editor will attach tease(s) to episodes based on air order/premiere plan, after master and tease deliveries.]

## Next on teases Guidance specific to series with stand-alone eps

- Next on teases are required for the third episode in the air order through the finale episode.
- <u>Upload each tease under the episode featured in that next on tease.</u> For additional clarity: don't think about air order when uploading the teases. Example: a tease of content from episode **2** should be uploaded under episode **2**.

- "ON THE NEXT" text above the title graphic / series name
- + a narrator stating the words shown (if series has a narrator)
- 1-2 seconds max

#### **Episode Content**

- Compilation of scenes per previous instructions
- 18 seconds max
- No title end card needed / end on content

## Next on tease Guidance specific to Limited Series "doc-busters":

## needed only in the instance of a 3 day/night consecutive premiere (ex: a 5x60)

- Extended promotional content for what the audience can expect to see in the day/night 3 episode(s).
- Features the best and most salacious bites/scenes/images from upcoming episode(s) in night 3, but <u>no</u> material from the nights 1&2 episode(s).
- If there are 2 episodes premiering on day/night 1, and 2 episodes premiering on day/night 2, then final/approved version portal upload should go <u>under episode 4</u>.

#### Night 3 content only

- Compilation of scenes per previous instructions
- 18 seconds max
  - No title end card needed / end on content
